ComSoc/IETE - Main Agreement

THE COMMUNICATIONS SOCIETY (COMSOC) of THE INSTITUTE OF ELECTRICAL AND ELECTRONICS ENGINEERS, INC. and

THE INSTITUTE OF ELECTRONICS & TELECOMMUNICATIONS ENGINEERS (IETE)

Cooperation Agreement

The agreement, signed/renewed the 12 to 0 fold 2013, is between the Communications Society (ComSoc) of the Institute of Electrical and Electronics Engineers, Inc. (IEEE) and The Institute of Electronics and Telecommunications Engineers (IETE), hereafter referred to as the "Organizations". "Members" hereafter refer to individual members, not corporate members

To implement this agreement, the following conditions are agreed upon by the Organizations:

- I. Members of ComSoc may submit papers to IETE-sponsored meetings with the same privileges and limitations as IETE members. Conversely, members of IETE may submit papers to ComSocsponsored meetings with the same privileges and limitations as ComSoc members.
- II. Members of IETE (ComSoc) may register for ComSoc (IETE) sponsored meetings at IEEE (IETE) member rates. To implement this procedure, IETE (ComSoc) members must indicate on the registration form or at the registration desk that he or she is a member of IETE (ComSoc).
- III. Members of IETE (ComSoc) may subscribe to ComSoc (IETE) publications at reduced Sister-Society rates (reference Publications Side Agreement).

The following stipulations apply:

- A. IETE (ComSoc) members may purchase individual ComSoc (IETE) publications separately.
- B. Each Society will review sister-society rates for publications annually; rates for a given year should be set by the 30th of June of the preceding year.
- C. Subscription rates for each Society will include an option to receive publications via airfreight at a price set by the Society.
- D. Each Society's publications will be shipped directly from the printer to the respective individual subscribers; there will be no bulk shipments of publications.
- E. Each Society will promote the sale of the other Society's publications to its members by including advertisements in promotional literature and publications; promotions by IETE and ComSoc will be within legal limits permitted to non-profit organizations.
- F. ComSoc (IETE) will invoice IETE (ComSoc) subscribers to their publications annually; individual subscribers will make subscriptions payments to the sister society.
- IV. ComSoc will provide Affiliate Membership to IETE members providing the same privileges as ComSoc members for ComSoc publications subscriptions, access capabilities to ComSoc on-line publications, and technical activities.

The following stipulations apply:

- A. Regular IETE Members (or higher grade) are eligible for Affiliate Membership in ComSoc.
- B. ComSoc will review the Affiliate Member fee annually; the fee for a given year should be set by the 30 of June of the preceding year.
- C. An Affiliate Member will automatically receive *IEEE Communications Magazine* monthly at no additional cost.

- IETE will promote ComSoc Affiliate Membership by including advertisements, application forms (prepared by ComSoc) in IETE promotional literature, and publications.
- V. ComSoc (IETE) will give privileges to IETE (ComSoc) and cooperate with each other to promote mutual prosperity.

Both Organizations agree to the following items:

- ComSoc will publish (in any of its magazines) at least one article every year (in English) prepared by IETE on feature topics to be commonly agreed. An officer from IETE will manage the preparation of these feature articles, submitting them for publication in collaboration with the ComSoc Director of Magazines (reference Publications Side Agreement).
 - IETE will publish (in any of its publications) at least one article every year that has appeared in a ComSoc magazine or journal in collaboration with IETE Directors and ComSoc Directors of Magazines and Journals (reference Publications Side Agreement).
- ComSoc may provide technical co-sponsorship to established IETE sponsored meetings and B. conferences following the ComSoc M&C annual review process, waiving the technical cosponsorship application fee. Other IETE meetings and conferences may be reviewed on a case-by-case basis to determine whether ComSoc technical co-sponsorship will be conferred.
- IETE will publicize the ComSoc web site and its URL by including advertisements prepared C. by ComSoc in IETE publications.
- D. IETE (ComSoc) will make its mailing list available for use by ComSoc (IETE) to promote their events.
- IETE members may fully participate in ComSoc Technical Committees; they are eligible to E. be Technical Committee Officers and to vote in Technical Committee elections.
- F. ComSoc will include in its sister society web site information provided by IETE on a yearly basis or as frequently as appropriate; information may include pointer to their web site, list of society events, goals, structure, contact information, etc.
- This agreement is valid for the calendar years 2014 2017 (4 years) and is renewable for an additional four-year term by written consent of both parties after the 30th of April of the fourth year.
- VII. Either Organization may withdraw from this agreement at any time upon written notification to the other Organization at least one year in advance. The effective date of termination shall coincide with the end of the calendar year.
